

## **Sher Le Mon 2021 Season rules** (V1)

Please note these are the rules based on the guidelines we have as of 6/5. As the summer goes on they may change, and we expect if things continue to progress positively in the state they will change. If so you will be made aware as quickly as we can via signs at the club, email notice or printed versions distributed at club.

### **GENERAL CHANGES**

1. Initially guests will be capped daily at 15-20. We will monitor the guest situation over the first week or so to determine the number and adjust as needed. We are not going to take reservations for guests as we did last year but you are welcome to call ahead to see what the guest count is at the time. If things continue to progress in a positive direction we may increase or even eliminate the cap.
2. The game room will be open. You may bring your own equipment or borrow from the front desk as in years prior to 2020. Game balls will also be available for use if you choose.
3. We will be issuing membership cards this year and like years prior to 2020 you can pick them up on your first visit to the club.
4. Birthday parties will be allowed this year but limited to no more than 10 children to start. No large parties of any kind will be allowed at this time.
5. You can be paged when food deliveries arrive but please conduct the payment transaction outside the building away from the front door.
6. We anticipate there will be a cap on the number of individuals who will be allowed inside the club for the Cumberland fireworks on July 3<sup>rd</sup> to ensure there is ample room for distancing that may be required. The evening's events and plans are currently being discussed. More information regarding the details will be shared shortly so you can make your plans accordingly.

### **CAPACITY**

1. We are back to the pre-COVID capacity formula the state dictates for all pools so therefore do not foresee a need to limit capacity lower than those rules allow. All the chairs have been placed on the deck this year but we ask that you are considerate of others based on the vaccination status of your group.

### **WHILE IN THE CLUB**

1. We are following the recommendation from the State of RI (based on CDC recommendations) in terms of mask and distancing requirements this year. Please stay current with those recommendations and be considerate of other members. We will also share as we learn of changes. As of this time this is the rule from the State Agency governing pools...

Face coverings shall be worn in accordance with applicable state laws and regulations.

2. No one should be wearing a mask if swimming in the pool.
3. As per pre COVID times, the bathrooms, showers and changing rooms will be available for use this year.

4. The playground will be available for use.
5. Barbeque grills will be available for use. You must supply your own cooking utensils and maintain the appropriate separation while in use.

#### OUR ROUTINES

1. We are not mandated to continue the same chair and bathroom disinfecting routines as required in 2020, but are always committed to a clean safe environment. Therefore the Men's and Ladies bathroom will be cleaned periodically throughout the day at an appropriate interval based on the number of individuals in the facility.

#### WHAT CAN YOU DO TO HELP ?

1. ALWAYS be considerate of other members.
2. Stay current with the State and CDC guidance regarding use of masks and distancing based on vaccination status.

Some of you have not completed the waiver for 2021 and will be asked to do so when you pick up your membership cards. For that reason an adult may have to request the cards. The waiver is available on the membership page if you wanted to print it ahead so you can bring it completed and signed or we will give you one to complete.
